1. Protection of personal data

We are pleased about your interest in our company and our products and services provided, and, while visiting our website, we want you to feel safe, especially considering your personal data. We take the protection of your personal data very seriously. Following the provisions of GDPR it is regarded a matter of course. We want you to know when and what kind of data is collected, and how we use it. Technical and organisational measures have been taken to secure the compliance with data protection both by us, and external service providers.

2. Anonymous data processing

You can generally visit the websites of Gem-Uk Garage Ferring Ltd without telling us who you are.

3. Personal data

Personal data is information about your identity, e.g. information about your name, address, phone number, e-mail address. It is not necessary to provide personal data to use our website. In particular cases we need your name and address as well as further information, for providing service. Similarly, to receive information and ordered products, or for answers of personal questions. If this is necessary, we will point that out. Furthermore, we only save and process data, which is given to us voluntarily, and if necessary, data that is automatically collected when visiting our website (e.g. your IP-address and the name of the websites recently visited, the browser and the operating system you are using, date and time of the access, used search engine, name of downloaded data). If you request services, we will only collect the data which is needed to accomplish the service. If we ask you to provide further data, this is to be regarded as voluntary statement. The procession of personal data only occurs for providing the asked service, and for the protection of own just business interest.

4. Purpose specification of personal data

The personal data offered by you will generally be used to answer your inquiries, to carry out your order, or to grant access to specific information or offers. To retain the relationship with clients it might be necessary that we will use this personal data to inform you about product range. We will not sell your personal data to third parties or capitalize on them in any other way.

5. Purpose limited usage

The personal data offered online by you will only be collected, processed or used for the purpose you were informed about. A transmission of your personal data to third parties will not take place without your clear consent. The collection of personal data as well as the transmission of the latter to public institutions entitled to receive information, and authorities will only take place according to the relevant laws, or rather if we are obliged by a court decision to do so. Our employees are obliged to maintain confidentiality, and to comply with the provisions of GDPR legislation.

6. Export and data processing outside of the European Economy Community

Generally no data is exported to states outside of the European Economy Community. Therefore, no data which is processed, stored or used otherwise on the websites of Gem-Uk Garage Ferring Ltd, stored or used outside of the European Economy Community.

7. Data, which will be automatically collected when visiting our website

When using our website, the following data will be saved due to organisational and technical reasons: the name of the sites you visited, the name of the browser you are using and your operating system, date and time of your visit, used search engines, name of downloaded data and your IP address.

8. Use of Google Analytics

This website uses Google Analytics, a web analysis service of Google Inc. ("Google"). Google Analytics uses so called "cookies", text files which will be saved on your computer and which allow an analysis of the usage of this website by you. The information generated by the cookie about your usage of the website will, as a rule, be transmitted to and be saved on a server of Google in the USA. However, in case of an activation of the IP anonymisation on this website, your IP address will be shortened by Google within the member states of the European Union, or within other contracting states of the treaty about the European economic area. The entire IP address will only in exceptional cases be transmitted to and then be shortened on a server of Google in the USA. Under contract to the operator of this website, Google will use this information to evaluate your usage of this website, to collect reports about website activities, and to provide further services for the operator, related to website usage and internet usage. The IP address, transmitted according to Google Analytics by your browser, will not be combined with other data of Google. By using a certain setting of your browser software, the saving of cookies can be avoided; however, we need to point out that you might not be able to use the entire functions of the website. Furthermore, you can also avoid the collection of personal data by the cookie and the data related to your usage of the website (including your IP address) to Google, as well as the processing of the former by Google, by downloading and installing the browser plugin when using the following link https://tools.google.com/dlpage/gaoptout?hl=en-GB

9. Cookies

If you are visiting one of our websites it might be that we will deposit information in form of a cookie on your computer. Cookies are small text files that will be sent to your browser by a webserver and will be saved on the hard drive of your computer. Except the Internet Protocol address no other personal data of the user will be saved. This information will be used to recognize automatically you when you are visiting our website again and to ease the navigation for you. Cookies allow e.g. to adapt the website according to your interest or to save your password, so you do not need to type it in again. Our website can also be viewed without using cookies of course. If you do not want us to recognize your computer again, you can avoid the saving of cookies on your hard drive by setting "do not accept cookies" in your browser. To see how that works in detail, please see the instructions of your browser. If you do not accept cookies this might lead to a limitation of the functions of our offers.

10. Children and teenagers

People under 18 should not transfer personal data to us without having the permission of parents or the legal guardian. We do not ask for personal data of children or teenagers, nor do we collect them or transfer them to third parties.

11. Security

Technical and organisational security measures were made to keep your personal data safe from loss, destruction, manipulation, and unauthorised hits. All employees and every person concerned with data processing, need to comply with GDPR legislation and other laws being relevant to data protection as well as with the confidential use of personal data. Our security measures are regularly maintained according to technological developments.

12. Change of our data protection code

We reserve the right to change out security measures and data protection measures according to technical developments if necessary. In this case our policies on data protection will be adapted as well. Please note, therefore, the latest version of our data protection notice.

13. Links

If you are using external links offered on our websites, our data protection notice will not be used on this links. If we offer links, we ensure that when having placed the link on our site, there was no breach of the law on the other website. However, we do not have any influence on the obeying of data protection and security provisions of other providers. Please see therefore the data protection notice on the websites of other providers.

14. Right of access
